But in parallel, they activated Reveal's predictive AI, letting the technology run in the background during the initial review. Once the first pass was complete, Reveal flagged an additional 20,000 documents that had been previously tagged as non-responsive but scored 98% or higher as likely responsive.



Instead of discarding those results, Premier conducted a targeted second-tier review using Reveal's scoring logic and AI prioritization. That effort uncovered ~2,800 additional responsive documents that the team had missed the first time around.

This AI-human synergy didn't just improve efficiency; it safeguarded the integrity of the review. Reveal effectively served as a continuous quality control layer, surfacing hidden signals and enabling the team to pivot swiftly as new patterns and themes emerged. The result was a more defensible, accurate, and agile review process, proving that pairing human judgement with advanced AI can redefine what's possible in legal investigations.
